C-1: RECENT EXPENDITURES ON ACTIVE TRANSPORTATION

Over the past five years, beginning with fiscal year 2011/2012, the cities and unincorporated areas of Kern County have invested over \$26 million in active transportation improvements. Of this, almost 90 percent is attributed to bicycle and pedestrian improvements throughout the county. The remaining 10 percent is attributed to programs, such as Safe Routes to School. A breakdown of these recent expenditures is presented in the following tables.
